Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2022

Limerick City and County Council in exercise of the powers conferred on it by Section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), hereby makes the following bye-laws in respect of the area comprising the administrative area of the County of Limerick.

The maps annexed to these bye-laws are for illustrative purposes only and in the event of a conflict between the maps and the text of the Schedule hereto, the text of the Schedule shall take precedence.

1. These Bye-Laws may be cited as the Limerick City and County Council Road Traffic (30 kilometres per hour Special Speed Limit) Bye-Laws 2022
2. These Bye-Laws shall come into operation on the 30th day of November, 2022.
3. In these Bye-Laws:
 - “the Act of 2004” means the Road Traffic Act, 2004 (No. 44 of 2004);
 - “local road” has the meaning assigned to it by the Act of 1993;
 - “regional road” has the meaning assigned to it by the Act of 1993;
 - “road” means a public road and includes a motorway.
4. The provisions of the Limerick City & County Council County Limerick Road Traffic Special Speed Limit Byelaws 2019 for National, Regional & Local Roads, insofar as they apply to any of the roads or part thereof referred to in the below text of these Bye-Laws are hereby amended insofar as they relate to the said roads or part thereof with effect from the date on which these bye-laws come into effect.

The following roads at Ballinacurra:

- a) All roads within the housing estates of **Verona Esplanade and Verona Park** from its junction with O'Connell Avenue R-526
- b) All roads within the housing estate of **Emmett Place** from its junction with St. Josephs St L-10401
- c) All roads within the housing estates of **Vizes Court and Little Saint Josephs St** from its junctions with St. Josephs St L-10401 and Bowman St L-10403

- i) All roads within the housing estate of Moylish Avenue from its junction with the Moylish Rd L-10008
- j) All roads within the housing estate of Ballynanty Avenue from its junction with the Moylish Rd L-10008
- k) Shannabooly Avenue L-10011 from its junction with the Shannabooly Rd L-10003 to its cul de sac.
- l) Ballygrennan Rd L-10010 from its junction with the Ballynanty Rd L-10012 to its junction with the Moylish Rd L-10008
- m) Ballynanty Rd L-10012 from its junction with the R-464 Killeely Rd to its junction with the Moylish Rd L-10008
- n) Killeely Rd L-10015 from its junction with Ballynanty Rd L-10012 to its junctions with the Knockalisheen Rd L-10013

The following roads at Ballysimon:
